WPBT2 also produces Changing Seas, an award-winning science series and uVu, an online community video and social networking initiative connecting individuals and organizations across the region. a major education program service is Kidvision VPK, an online training resource for early learning educators, daycare providers and parents.

4b (Code:) (Expenses \$ 98,156. including grants of \$) (Revenue \$ 296,453.) WPBT2 produced programs designed to highlight Arts and Cultural Heritage in South Florida. These initiatives focus primarily on Hispanic programming and a new series called Art Loft.

4c (Code:) (Expenses \$ 341,589. including grants of \$) (Revenue \$ 534,580.) Community Television Foundation of South Florida, Inc. provides facilities and crew for the production of the program "Nightly Business Report" (NBR), a 30-minute business news program broadcast daily to 200 public television stations nationwide. It is distributed by American Public Television.
